



## Business for Peace (B4P) Launch Event 17-18 November 2014

# "Collaborative Partnership Approaches towards Advancing Peace and Sustainable Development."

#### **Background**

The business leadership platform <u>Business for Peace (B4P)</u> was launched by UN Secretary-General Ban Ki-moon at the UN Global Compact Leaders Summit in September 2013. Since then, a group of Global Compact Local Networks have mobilized their members to join this global effort to support peace, including among others Turkey, Indonesia and Colombia. As of today, over 120 Global Compact corporate participants from various sectors and regions have joined this movement. The Global Compact Network Sudan is convening the B4P launch in Khartoum on 17-18 November 2014.

The B4P leadership platform is designed to expand and deepen private sector action in support of peace in the workplace, marketplace and local communities. To overcome years of multiple conflicts, bringing sustainable peace and economic development to Sudan will require the efforts and collaboration of business with other stakeholders. Together they can strengthen the positive contribution of the private sector to help build a strong economy and prosperity, establish more stable and just societies, foster tolerance and create trust.

To this end, the Global Compact Network Sudan is dedicated to building a national B4P platform and to assist companies better manage business risks and opportunities, engage in public-private dialogue, and align business strategies and operations with good practices to promote peace, security and development. This effort will enhance the capacity of the Network and identify priority areas of focus, while also building off of the Global Compact's Africa Strategy (Partners in Change: UN Global Compact Advancing Corporate Sustainability in Africa), which was launched recognizing that businesses have an unprecedented opportunity to contribute to the United Nations Post-2015 Development Agenda and scale up sustainable development in the region.

#### **Objectives**

- Introduce the new B4P platform, its rationale and modalities in Sudan.
- Highlight the importance of business engagement in multi-stakeholder dialogue and collaborative efforts in support of peace.
- Prioritize areas of focus for B4P in Sudan and identify projects through which business can enhance its positive contribution to local peace.
- Showcase best practice examples from Sudan and around the world with a view to inspire action.
- Mobilize private sector action that can contribute to peace.

#### **Event participation and structure**

The B4P launch event will take place over two days on 17 and 18 November and will be convened by the Global Compact Network Sudan. It will bring together a core group of Sudanese companies committed to advance peace in Sudan, and to drive B4P in the country by demonstrating active commitment and leadership. Further participants will include non-business civil society organizations, academics, business associations, government and UN representatives from Sudan, as well as foreign companies and other organizations with operations and interests in the country.

The event will be structured around five main pillars:

- 1. The B4P platform, and the need for private sector engagement in challenging environments:
- 2. Sharing Experiences and Examples for Partnership: NGOs, Academia and Youth
- 3. Sharing Experiences and Examples for Partnership: Multinational Business Experiences.
- 4. Darfur Business Partnership Interventions
- 5. Exhibitions to demonstrate: B4P blueprint / guidelines: how to advance sustainability through education, jobs, sustainable water management and agriculture.

The event will have a separate session on Darfur business interventions and reflections on the ground. The event will also witness a joint pledge at the regional level between business federations of South Sudan and Sudan, to catalyze the role played by sustainable business within state and cross-border peace building.
